### Rule 17 parts a), b), and c)

- a) The Club shall not have more than 5 adopted Senior classes and 2 Junior classes. In addition, there shall be a Handicap fleet.
- b) The current adopted Senior classes shall be Streaker, International Enterprise, International GP14, International Laser and Solo. The adopted Junior classes shall be the International Optimist and the International Topper.
- c) The handicap fleet shall comprise of boats purchased by the Club under Rule 17(I) and of any sailing dinghy within the current Portsmouth yardsticks up to a maximum of 1500 inclusive, up to and including 4.6 metres in length, which are monohulls and are governed by a recognised National Authority, subject to the discretion of the General Committee which will consider all applications.

#### Bye-Law 7

Any member wishing to bring a boat on site will notify the Harbourmaster of the class, sail number and insurance details on a Boat Registration Form.

The Harbourmaster will consider the application, and if approved will register the boat in the Club records. If requested (on the boat registration form) the harbourmaster will then allocate a boat berth, having regard to the facilities available. The Harbourmaster will advise the Hon. Membership Secretary by passing on the Boat Registration form.

No boat can be left on site or sailed at the Club until this procedure has been completed, at which time the Harbourmaster will inform the Member of the successful application and / or berth allocated and will issue a sticker which must be displayed in a prominent position on the boat which remains readily visible when the boat is covered.

After written notice from the Harbourmaster, a member may be required to relinquish a berth previously allocated and accept a different berth within the Boat Park in the interests of good management of the Boat Park.

Members are responsible for securing and covering their boats and maintaining their boat berth in a neat and tidy condition. Road trailers cannot be left on the site except in an allocated boat berth and must be immobilised for the sake of security.

The club grounds are not a secure site and can be subject to severe weather and flooding. The Club will accept no responsibility for loss or damage howsoever caused. Members are advised to inspect their boats regularly and especially during and after severe weather or flooding.

The full Club Rules & Bye-laws are available in the clubhouse and on the website
